I understand that while participating in any of the activities during the camp, I may be photographed. I agree to allow my photo(s), videos, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

Release and Waiver of Liability: I, for myself and my heirs, assigns, successors, and personal representatives, hereby release, waive, discharge, and covenant not to sue Vietnamese Refugee Heritage Camp (VRHC), Camp Copass, Vietnamese Heritage Museum (VHM), their directors, officers, employees, volunteers, agents, and representatives collectively, or any affiliated partners, from any and all liability, claims, demands, losses, or damages (collectible damages, general damages, or any other type of damages, known or unknown, foreseen or unforeseen) arising out of or in any way connected with my participation in the camp. This release includes, but is not limited to, any injuries, illnesses, or property damage sustained by me while participating in the VRHC camp and its activities.
